OH&S CODE REVIEW

Part 4 Chemical Hazards,
Biological Hazards and
Harmful Substances

General Requirements

Exposure during shifts
longer than 8 hours

18(1) Subject to subsection
(3), if a worker is exposed
to a substance listed in
Schedule 1, Table 2 during
a single work shift that is
longer than eight hours, the
employer must ensure that
equivalent protection from
adverse health effects is
achieved by adjusting the
eight-hour exposure limit
using the following
formulas: adjusted
exposure limit = eight-hour
occupational exposure limit
x daily reduction factor
where the daily reduction
factor

$$= \left\{ \frac{8}{h} \times \left(\frac{24 - h}{16} \right) \right\}$$

And h=hours worked per day

Emergency Response Procedures

In accordance with Workplace Safety and Occupational Health and Safety regulations, Swab Master Ltd. is required to develop Emergency Response procedures to ensure that all personnel on site can be assisted and cared for in time of need or be evacuated to a safe area when life threatening situations arise.

Emergency Response procedures are put in place to assist personnel in time of life-threatening situations. *Such emergency response procedures in place for Swab Master Ltd are considered conditions of employment and must be always followed while on site.*

Emergency Response procedures are discussed at pre-job safety meetings and all employees are made aware of the location of:

- Safe site (Muster point)
- Emergency phone numbers
- Cell phones and / or other means of contact

All personnel are required to help implement and maintain the emergency response plan by:

- Discussion
- Monitoring effectiveness of emergency response plan
- Awareness
- Adherence to the procedures
- Training

Note: *Because the work environment is not static and is continually changing, the emergency response plan (s) must be reviewed as activity progresses to ensure that the plans are current and applicable for the work area.*

You are responsible for understanding the Emergency Response Plan. This document can be found at each exit in the shop / office and on our website. Know and familiarize where to find your emergency exits, fire extinguishers and air horns. These are to be used in evacuations only. Sounding the blow horns for "fun" will result in disciplinary action. Know and familiarize yourself with the emergency procedures in the company safety manual, Element 8.
