OH&S CODE REVIEW

Part 4 Chemical Hazards, Biological Hazards and Harmful Substances

General Requirements

Worker exposure to harmful substances

16(4) If no 15-minute occupational exposure limit or ceiling occupational exposure limit is listed for a substance in Schedule 1, Table 2, the employer must

- (a) comply with the eight-hour occupational exposure limit, and (b) ensure that a worker's exposure to that substance does not exceed
- (i) three times the eighthour occupational exposure limit for more than a total of 30 minutes during a continuous 24hour period, and five times the eight-hour occupational exposure limit, or
- (ii) the concentration that is immediately dangerous to life and health, whichever is lower.





- **Tickets** Things to double check before tickets are signed off by the company rep:
 - 1. Date Make sure it is entered correctly!
 - 2. Unit number Make sure you enter the correct unit number – you don't drive the same unit every day!
 - 3. Missing Cost/AFE numbers You should have a way to search these!
 - Fuel reports Use proper codes & exact litres! DO NOT ROUND LITRES FROM THE PUMP - USE TWO **DECIMAL FORMAT - EXAMPLE: 45.58 L**
